#### Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014

#### 109 Functions and powers

- (1) The Maunga Authority has the powers and functions conferred on it by or under this Act or any other enactment.
- (2) In exercising its powers and carrying out its functions in relation to the maunga, the Maunga Authority must have regard to—
- the spiritual, ancestral, cultural, customary, and historical significance of the maunga to Ngā Mana Whenua o Tāmaki Makaurau; and
- (b) section 41(2).
- (3) In exercising its powers and carrying out its functions in relation to the administered lands, the Maunga Authority must have regard to the spiritual, ancestral, cultural, customary, and historical significance of the administered lands to Ngā Mana Whenua o Tāmaki Makaurau.

#### [Emphasis added]

#### 41 Maunga must remain as reserves vested in trustee

- (1) This section applies to each maunga once the maunga is—
- (a) vested in the trustee under subpart 1, 2, or 3 of this Part;

and

- (b) Declared a reserve under any of sections 18 to 29, 33, and 39.
- (2) The maunga is held by the trustee for the common benefit of Ngā Mana Whenua o Tāmaki Makaurau and the other people of Auckland.

#### **Background**

- 1. The Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Tūpuna Maunga Authority and Auckland Council to agree an annual operational plan and a summary of that plan for inclusion in council's annual plan.
- 2. As part of the development of the annual operational plan for 2024/25, management also prepared a draft Tūpuna Maunga 10-year budget to be included in Auckland Council's draft 10 Year Budget (Long Term Plan) 2024-35.
- 3. The Draft Operational plan 2024/25 represents a continuation of the funding and activity indicated in previous financial planning. Management are not proposing substantive changes to the operational plan for the coming financial year.
- 4. Minor adjustments have been made to the 2025/26 and 2026/27 projects in the light of more accurate financial projections and costs. The overall budget for the three years of the operational plan is unchanged.
- 5. The outer years of the proposed 10-year budget reflect a transition from a substantial capital works programme to a focus on maintaining assets, and funding operational programmes.

#### **Statutory Context**

- 6. The process and any decision to adopt an Operational Plan, and summary thereof, is required to take into account the legislative and policy framework.
- 7. Section 109(2) of Ngā Mana Whfenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
- 8. The Tūpuna Maunga Authority's Integrated Management Plan was adopted by the Authority pursuant to the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga.
- 9. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation,

- commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.
- 10. The Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 sets out a process for the adoption of an "Annual Operational Plan" by the Authority (refer sections 60-63). Management have worked alongside the council's legal and finance teams to ensure compliance with the procedures set out in the legislation.
- 11. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also applicable in relation to Maungauika.

#### **Draft Operational Plan 2024/25**

- 12. Management are not proposing substantive changes to the operational plan for the coming financial year. Any changes to the plan will stay within the Long-Term Plan funding envelope agreed in May 2023.
- 13. The draft Operational Plan 2024/25 is appended to this report as Attachment A. It sets out the proposed work programme for the financial years 2024/25, 2025/26 and 2026/27 in detail. It also includes a ten year work programme overview and an indicative funding envelope for the next seven years.
- 14. While the bulk of the operational plan is a continuation of the previous work programme, key changes to the programme are as follows:
  - The inclusion of a budget line to understand and plan for climate resilience. This will
    initially cover planning for infrastructure changes on the maunga, and may be extended to
    fund construction in particular for any remedial works required from recent storm events.
    The work will consider the possible impact of increased storm events on the maunga, and
    infrastructure changes to manage that.
  - An increase over time to the operational budget. This change is proposed on a small scale
    in the initial three year to fund additional staff. Over the ten year period, the proposed
    increase to the operational budget extend to cover maintenance of new assets,
    programming, outreach and consequential OPEX.
  - Further analysis of the potential revenue generation opportunities has confirmed the predicted increase in this area.

#### Maintenance contracts

- 15. The Maunga are currently maintained within a full facilities maintenance contract model. The cost of that contract in included in the operational plan and is adjusted annually for inflation. The contract is current until July 2027.
- 16. Management have completed a high level analysis of the contract spend in order to provide an estimate of what it might cost to carry out the maintenance contract activities in-house.
- 17. An estimated 16 FTE positions would be required to cover the mowing, cleaning, horticulture, response and repair, and management functions within the contract. Including the costs of maintaining an FTE position, this would account for \$1.4m/annum.
- 18. Management would also need to fund the purchase and ongoing maintenance of a significant amount of plant and equipment, and the lease or purchase of up to 10 vehicles. To acquire these assets is estimated at \$1m.
- 19. The team would need to be accommodated in a depot with storage. All of the consumables required by the maintenance teams would also need to be sourced and supplied.
- 20. The outcome of this high level consideration is that there will be little or no financial benefit to sourcing this area of operation in-house. There may be non-financial benefits such as quality assurance but these have not been quantified.
- 21. Over the period of the next LTP management will continue to keep under review the operational model and ensure it is the most fit for purpose and considers value for money.

#### **Next steps**


- 22. Once approved by the Maunga Authority, the Auckland Council's Governing Body will be invited to approve the Authority's operational plan, including a summary of the Operational Plan for inclusion in the council's draft Annual Budget 2024/25.
- 23. The indicative timeframes for the development and adoption of council's Annual Plan 2022/23 are:
  - Decision making on the draft Operational and Mayoral proposal/consultation documents:
     December 2023
  - Public Consultation by the Authority and Auckland Council: February to March 2024
  - Joint workshop of Authority and Auckland Council: anticipated end of April 2024
  - Deliberations: April to May 2024
  - Adoption of Operational Plan as final: by end of June 2024.
- 24. The Maunga Authority will, as in previous years, carry out its own consultation process on the annual operational plan alongside the council's process.

## Ngā Tūpuna Maunga o Tāmaki Makaurau

The ancestral mountains of Auckland

It is the rich history of Māori connection to the Maunga (volcanoes) of Tāmaki Makaurau / Auckland, unbroken over time, that sets them apart from any other volcanic landscape in the world.

As Māori established here, the Maunga were valued as natural places for pā (settlements), with their rich volcanic soils and their unique form and height for easy defence. The number of Maunga pā across Tāmaki Makaurau made it an important region of Māori social organisation and a main location for trade between tribes throughout Aotearoa / New Zealand.

## The Maunga are central to the spiritual and cultural identity of Māori.

A defining principle in te ao Māori (the Māori world) is kinship. All the myriad elements of creation - the living and the dead, the animate and inanimate - are inter-related. All are infused with mauri (life force) and wairua (spirit), and all are related through whakapapa (common descent) from Ranginui (Sky Father) and Papatūānuku (Earth Mother).

In Māori culture, the people of a place are related to its mountains, rivers and species of plant and animal, and regard them in personal terms. Wairuatanga (spiritual

connections) between people and the natural world is an integral part of traditional Māori cultural practices.

Tikanga (protocols) have been established over time to ensure that resources are harvested sustainably and that the relationship with the natural environment remains balanced. The Maunga, as with all of the natural environment, are governed by fundamental values such as kaitiakitanga (guardianship), manaakitanga (care and generosity) and utu (reciprocity) which reinforce a sense of belonging and social cohesion.


To Nga Mana whenua o Tāmaki Makaurau (the Māori tribes of Auckland), the Maunga are living entities with mauri and wairua. They are regarded as Tūpuna (ancestors), and as taonga tuku Iho (treasures to be handed down the generations).

In recognition of the deep spiritual, cultural and customary connection between the Maunga and the Māori people of this land, the Auckland volcanic field heads New Zealand's working list for World Heritage status with the United Nations Educational, Scientific and Cultural Organisation (UNESCO).

## The Tūpuna Maunga Redress

The Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Settlement is an outcome of Mana Whenua and the Crown settling historical Treaty of Waitangi breaches. The settlement recognises that the Tūpuna Maunga are taonga in relation to which Mana Whenua have always maintained a unique relationship and honours their intergenerational role as kaitiaki (guardians).

In July 2014, the Collective Redress Act was passed. The Act vested the Crown-owned land of 14 Tūpuna Maunga in Ngā Mana Whenua o Tāmaki Makaurau, on the basis that they are held in trust for the common benefit of the iwi/hapū of Ngā Mana Whenua o Tāmaki Makaurau and the other people of Auckland.

The Tūpuna Maunga are owned by the 13 iwi/hapū of Ngā Mana Whenua o Tāmaki Makaurau via the Tūpuna Taonga o Tāmaki Makaurau Trust.

Under the Act each Tūpuna Maunga was declared a reserve and the Tūpuna Maunga Authority was appointed as the administering body for the majority of the Maunga for the purposes of the Reserves Act 1977.

#### THE EXCEPTION IS:

 Rarotonga /Mount Smart which is vested in the Taonga Trust and administered by Auckland Council (Regional Facilities Auckland) under the Mount Smart Regional Recreation Centre Act 1985 and Reserves Act 1977.


The Collective Redress Act also transferred the administration of the following reserve land retained in Crown ownership to the Tūpuna Maunga Authority:

- Te Pane-o-Mataaho /Te Ara Pueru/ M\u00e4ngere Mountain – ownership of the land remains with the Crown and is administered by the T\u00fcpuna Maunga Authority under the Collective Redress Act and Reserves Act.
- Maungakiekie / One Tree Hill Northern land ownership of the land remains with the Crown and it is administered by the Tūpuna Maunga Authority under the Collective Redress Act and Reserves Act.

#### NGĀ MANA WHENUA O TĀMAKI MAKAURAU

Ngā Mana Whenua o Tāmaki Makaurau is the collective name of the 13 iwi/hapū with historical Treaty claims in the wider Tāmaki Makaurau. The iwi/hapū are grouped into the following three rōpū:

- Marutūāhu Rōpū: Ngāti Maru, Ngāti Pāoa, Ngāti Tamaterā, Ngāti Whanaunga, Te Patukirikiri;
- Ngāti Whātua Rōpū: Ngāti Whātua o Kaipara, Ngāti Whātua Ōrākei, Te Rūnanga o Ngāti Whātua; and
- Waiohua Tāmaki Rōpū: Ngāi Tai ki Tāmaki, Ngāti Tamaoho, Ngāti Te Ata, Te Ākitai Waiohua, Te Kawerau ā Maki.

The collective approach recognises that the iwi and hapū have various shared customary interests within Tāmaki Makaurau such that a collective settlement approach is appropriate. It also provides for the greater exercise of whanaungatanga and kotahitanga between the iwi/hapū.

The sections for each of the Tūpuna Maunga within this document show the individual iwi and hāpu customary association with that Tūpuna Maunga as recorded in the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Deed of Settlement.

#### TŪPUNA TAONGA O TĀMAKI MAKAURAU TRUST

The Tūpuna Taonga o Tāmaki Makaurau Trust (Trust) was set up to receive the Tāmaki Collective cultural redress arising out of the Collective Redress Act.

The Trust receives, administers, manages, protects and governs the assets of the Trust for and on behalf of the 13 iwi and hapū of Ngā Mana Whenua o Tāmaki Makaurau.

The Trust's Statement of Intent 2017/18 confirms the Trust's strategic objectives as:

#### TŪPUNA MAUNGA AUTHORITY

The Tūpuna Maunga Authority is the statutory authority established under the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act to co-govern the Tūpuna Maunga. The inaugural hui was held in November 2014.

The Tūpuna Maunga Authority has six representatives appointed by Ngā Mana Whenua o Tāmaki Makaurau and six appointed by council. The Minister for Arts, Culture and Heritage may also appoint a non-voting Crown representative.

The Tūpuna Maunga Authority is independent of council and has its own decision-making powers and functions. Council is responsible for the routine management of the Maunga under the direction of the Tūpuna Maunga Authority.

The Tūpuna Maunga Authority's bespoke co-governance structure recognises not only the important relationship Ngā Mana Whenua have with these sacred places, but also their importance to, and connection with, all the peoples of Auckland. The Tūpuna Maunga Authority is a tangible expression of the spirit of partnership between Ngā Mana Whenua and council.

#### **AUCKLAND COUNCIL**

Auckland Council is responsible for the routine management of the Tūpuna Maunga under the direction of the Tūpuna Maunga Authority. It is responsible for the costs in relation to the Tūpuna Maunga and administered lands incurred by council and the Tūpuna Maunga Authority in carrying out their respective functions under the Collective Redress Act or the Reserves Act 1977.



#### TŪPUNA MAUNGA INTEGRATED MANAGEMENT PLAN

The Tūpuna Maunga Integrated Management Plan ("IMP") sets the foundations for how the Tūpuna Maunga are valued, protected, restored, enhanced, and managed in the future with equal consideration and reverence. The IMP established a set of Values for the Tūpuna Maunga which are outlined below.

The IMP was developed in accordance with Section 41 of the Reserves Act to provide for and ensure the use, enjoyment, maintenance, protection, preservation, and development as appropriate for the reserve purposes for which each of the Tūpuna Maunga is classified. This single integrated plan replaces the former separate legacy reserve management plans for the Tūpuna Maunga.

#### TŪPUNA MAUNGA INTEGRATED MANAGEMENT PLAN STRATEGIES

The Tūpuna Maunga Integrated Management Plan Strategies are the next level of policy development for the Tūpuna Maunga and aim to support the Values and Pathways in the Tūpuna Maunga Integrated Management Plan 2016.

The IMP Strategies was approved in 2019 following a public consultation process and can be read online at www.maunga.nz.

#### TŪPUNA MAUNGA INDIVIDUAL MAUNGA PLANS

The Individual Maunga plans (Maunga Plans) are the final tier of policy development and complete the series of documents as part of the Integrated Management Plan Framework. The Plans give effect to the Values, Pathways, Guidelines and Strategies and provide further detail with regards to the work the Authority is undertaking to enhance the health and well-being of the Tūpuna Maunga. The Maunga Plans are living documents that can be updated in accordance with future Annual Operational Plans.

The first 3 Maunga Plans were approved in July 2023. Further Individual Maunga Plans will be developed over the course of the current term of the Tūpuna Maunga Authority.

#### TŪPUNA MAUNGA VALUES

Within the Tūpuna Maunga Integrated Management Plan, the Tūpuna Maunga Authority has articulated a set of values of the Tūpuna Maunga. The values promote the statutory purpose of the Tūpuna Maunga under section 109 of the Collective Redress Act, where in exercising its powers and functions the Authority must have regard to the spiritual, ancestral, cultural, customary and historical significance of the Tūpuna Maunga to Ngā Mana Whenua.

The values provide a strategic framework to guide the Tūpuna Maunga Authority in making any decision about the Tūpuna Maunga.

The values weave together and give expression to mana whenua and other world views, and the connections and histories in a manner that highlights the way in which these views complement each other and create a richness to the relationship people have with the Tūpuna Maunga and multiple ways in which ways in which these relationships are thought of and expressed.

## The Tūpuna Maunga Authority Operational Plan

For each financial year the Tūpuna Maunga Authority and Auckland Council (council) must agree an operational plan. The plan outlines how council will carry out the routine maintenance of the Tūpuna Maunga (ancestral mountains) and administered lands under the direction of the Tūpuna Maunga Authority. This is a requirement under section 60 of the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 (the Collective Redress Act).

The operational plan outlines the work programme for the financial year, which comprises of a number of projects at a network and individual Maunga level. Importantly, the operational plan sets out how these individual projects contribute to delivery of the Tūpuna Maunga Authority's


objectives and vision for the Tūpuna Maunga by linking them to one or more of the Tūpuna Maunga Values in the Integrated Management Plan.

This Operational Plan covers the financial years 2024/25, 2025/26 and 2026/27 in detail. Network-wide budgets are shown for a number of programmes. Once the guidelines and strategies and individual Maunga plans have been developed, these will be able to be further refined to show spend on individual Maunga.

This Operational Plan also includes the funding envelope for the first year of the Auckland Council 10 Year Budget (Long Term Plan) 2024-34.

#### WORK PROGRAMME OVERVIEW

In addition to expressing the objectives and vision for the Tūpuna Maunga, the values are the key driver of the Tūpuna Maunga work programme (see Table 1).

This work programme is a continuation from the Long-Term Plan 2021-31. This year's operational plan reflects the progress that has been made on this programme and includes further projects which have emerged from the Tüpuna Maunga Strategies.

The outer years of the proposed work programme foreshadow a change in the focus of the Authority as the significant CAPEX projects are completed.

Priority programmes and projects over the next 3 years include:

#### POLICY AND MANAGEMENT

- Develop individual Tūpuna Maunga plans to provide direction on how the Values, Pathways, guidelines and strategies should be reflected on each Tūpuna Maunga.
- Progressing the potential transfer of administration over certain Maunga reserve lands from the Department of Conservation to the Authority, and the potential transfer of the administration of land contiguous to other Tūpuna Maunga
- Establishment of a compliance programme including a review of current and establishment of appropriate bylaws.

#### HEALING THE MAUNGA

#### VALUES:

TAKOTORANGA WHENUA / LANDSCAPE VALUE

- Protection and restoration of the tihi (summits) including reconfiguring space and provision of cultural infrastructure.
- Protection and restoration of historic kumara pits, pā sites and wahi tapu
- Development of infrastructure to enhance visitor experience including provision of carparks, amenity areas, tracks and ancillary infrastructure such as wharepaku/ toilets.

- Mana whenua living connection programme focusing on their role as kaitiaki (guardians), restoring customary practices and associated knowledge and enabling cultural activities.

- Restoration of indigenous native ecosystems; reintroducing native plants and attracting native animal species; removing inappropriate exotic trees and weeds (For context, see pages 58, 65-66, 71, 87,88 90-91, and appendix 5 of the amended Tūpuna Maunga Authority Integrated Management Plan, and at pages 7 and 34 of the Integrated Management Plan Strategies)

 Develop and implement a commercial framework which ensures continued investment back into the Tūpuna Maunga. This includes exploration of potential commercial activities and facilities, as well as the development of a concession framework for commercial operators on the Maunga. All projects are designed to deliver outcomes for the 13 iwi/hapū of the Tāmaki Collective and all the people of Auckland, enhance the mana and mauri of the Tūpuna Maunga and deliver improved open spaces across the eight local board areas.

They will also enable a compelling case in a future UNESCO World Heritage bid for the Tūpuna Maunga, which will contribute to a Māori identity that is Auckland's point of difference in the world. The bid for World Heritage status will require a dedicated resource and will continue to be progressed in this financial year in partnership with the Department of Conservation.

- projects that work with mana whenua to identify and implement infrastructure and programmes that will support mana whenua reconnecting with the Tūpuna Maunga,
- · a network-wide programme to work with mana whenua to identify, protect and heal sites of significance,
- · general engagement and consultation to seek technical and landowner input into projects and programmes; and
- supporting events where possible including mana whenua cultural activities.

Funding and revenue for the Tūpuna Maunga and administered lands may only be applied for the purposes of the Maunga and the administered lands.

Funding and revenue for the Maunga must be:

- Held and accounted for separately by council
- Applied by council under the direction of the Tūpuna Maunga Authority and in accordance with the annual operational plan

Every 3 years council must prepare and adopt a 10 Year Budget (Long Term Plan) which describes the activities of the council and forecast expenditure and funding requirements for the next 10 years.

The expenditure and funding requirements for the Maunga Authority for 10 years are included in the council's 10 Year Budget (Long Term Plan) 2024/34 are shown in Table 2.

This operational plan sets out the detailed expenditure and revenue for the 2024/25 and indicative financial information for 2025/26 and 2026/27. The annual operational plan for 2024/25 and the subsequent years fits within this funding envelope. The Tūpuna Maunga Authority manage the Maunga as a network. The individual Maunga sections set out maunga-specific costs for programmes and projects where these have been identified and scoped. The networkwide programmes require further project planning to determine how they will be applied to each Maunga.

Any budget variation associated with individual projects or network-wide programmes will be shared across the network in accordance with the priorities set out in Table 2 and kept within the total funding envelope.

#### **OPERATIONAL EXPENDITURE**

Net operating expenditure covers income and expenditure from day-to-day operations and services.

The operational expenditure shown in the individual Maunga sections is in future year dollar terms. The annual inflation rates applied are based on the rates used in the Auckland Council Long-term Plan 2024/34.

#### CAPITAL EXPENDITURE

#### CAPITAL DEVELOPMENT PROJECTS

These are for the creation or purchase of new assets, typically to address growth in demand, changes to the required Level of Service and to be consistent with the Tūpuna Maunga values and pathways as identified in the Integrated Management Plan. Any new Capital Project to be delivered are identified under each Maunga.

The Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 (the Act) requires the Tūpuna Maunga o Tāmaki Makaurau Authority (Tūpuna Maunga Authority) and Auckland Council to prepare an Annual Operational Plan and a summary of that plan for inclusion in the Auckland Council's Annual Operational Plan 2024/25 process.

The Tūpuna Maunga Authority and Auckland Council are required to approve the Annual Operational Plan. The Tūpuna Maunga Authority Operational Plan 2024/25 must be considered and adopted concurrently with the Auckland Council's Operational Plan 2024/25. A summary of the Tūpuna Maunga Authority's indicative funding requirements are outlined in this Section.

# NGĀ MANA WHENUA O TĀMAKI MAKAURAU

Ngā Mana Whenua o Tāmaki Makaurau negotiated a collective settlement of their historical Treaty claims with the Crown. Ngā Mana Whenua o Tāmaki Makaurau is the collective name of the 13 iwi/hapū with historical Treaty claims in wider Tāmaki Makaurau. The iwi/hapū are grouped into the following three rōpū:

# THE NGĀ MANA WHENUA O TĀMAKI MAKAURAU COLLECTIVE REDRESS ACT 2014

The Collective Redress Act 2014 vested the Crown owned land in 14 Tūpuna Maunga (ancestral mountains) in Ngā Mana Whenua o Tamaki Makaurau. They are held for the common benefit of the iwi/hapū of Ngā Mana Whenua o Tāmaki Makaurau and the other people of Auckland. The Tūpuna Maunga are vested as reserves under the Reserves Act 1977.

#### **CO-GOVERNANCE**

The Act also established the Tūpuna Maunga Authority, a bespoke co-governance entity, to administer the Tūpuna Maunga.

The Authority has six representatives from Ngā Mana Whenua o Tāmaki Makaurau, six from Auckland Council and one non-voting Crown representative appointed by the Minister for Arts, Culture and Heritage. The term of the Authority aligns with the term of the Council.

Under the Act, the Tūpuna Maunga Authority is the administering body for each Maunga for the purposes of the Reserves Act 1977, with two exceptions of Maungauika / North Head and Rarotonga / Mount Smart.

Maungauika / North Head has previously been administered by the Crown (Department of Conservation) but has now been transferred to the Tūpuna Maunga Authority. Routine management is now undertaken by council under the direction of the Tūpuna Maunga Authority in the same way as for the other Maunga.

Responsibility for administration and management of Rarotonga / Mount Smart remains with Auckland Council (Regional Facilities Auckland) under the Mount Smart Regional Recreation Centre Act 1985 and Reserves Act 1977.

The Tūpuna Maunga Authority is also the administering body for Te Pane-o-Mataaho / Te Ara Pueru / Māngere Mountain and the Maungakiekie / One Tree Hill northern land.

The legislation provides for funding and staff resourcing through Auckland Council. The Authority is currently supported by a core team of eight council staff across the Governance and Parks, Sport and Recreation units.

The scale of this co-governance arrangement is unparalleled in Auckland and the resulting unified and cohesive approach to caring for the Maunga has garnered widespread support.

#### STRATEGIC FRAMEWORK:

#### TŪPUNA MAUNGA INTEGRATED MANAGEMENT PLAN

The Tūpuna Maunga Integrated Management Plan ("IMP") sets the foundations for how the Tūpuna Maunga are valued, protected, restored, enhanced, and managed in the future with equal consideration and reverence. The IMP established a set of Values for the Tūpuna Maunga which are outlined below.

The IMP was developed in accordance with Section 41 of the Reserves Act to provide for and ensure the use, enjoyment, maintenance, protection, preservation, and development as appropriate for the reserve purposes for which each of the Tūpuna Maunga is classified. This single integrated plan replaces the former separate legacy reserve management plans for the Tūpuna Maunga.

The IMP was approved in 2016 following a public consultation process and are available at <a href="https://www.maunga.nz">www.maunga.nz</a>.

#### TŪPUNA MAUNGA INTEGRATED MANAGEMENT PLAN STRATEGIES

The Tūpuna Maunga Integrated Management Plan Strategies are the next level of policy development for the Tūpuna Maunga and aim to support the Values and Pathways in the Tūpuna Maunga Integrated Management Plan 2016.

The IMP Strategies was approved in 2019 following a public consultation process and are available at www.maunga.nz.

#### TŪPUNA MAUNGA VALUES

Within the Tūpuna Maunga Integrated Management Plan, the Tūpuna Maunga Authority has articulated a set of values of the Tūpuna Maunga. The values promote the statutory purpose of the Tūpuna Maunga under section 109 of the Collective Redress Act, where in exercising its powers and functions the Authority must have regard to the spiritual, ancestral, cultural, customary and historical significance of the Tūpuna Maunga to Ngā Mana Whenua.

The values provide a strategic framework to guide the Tūpuna Maunga Authority in making any decision about the Tūpuna Maunga.

The values weave together and give expression to mana whenua and other world views, and the connections and histories in a manner that highlights the way in which these views complement each other and create a richness to the relationship people have with the Tūpuna Maunga and multiple ways in which ways in which these relationships are thought of and expressed.

# TŪPUNA MAUNGA OPERATIONAL PLAN 2024/25

Each financial year, the Tūpuna Maunga Authority and Council must agree an annual operational plan to provide a framework in which the Council will carry out its functions for the routine management of the Tūpuna Maunga and administered lands for that financial year, under the direction of the Tūpuna Maunga Authority.

The Tūpuna Maunga Operational Plan 2024/25 identifies a number of projects to be delivered or commenced in the coming financial year and the subsequent two financial years. The Tūpuna Maunga Operational Plan 2024/25 also sets out the 10-year work programme and funding envelope confirmed through the Long Term Plan 2024-2034. The budget for 2024/25 and the subsequent years fits within this funding envelope.

# PRIORITY PROGRAMMES AND PROJECTS OVER THE NEXT 3 YEARS INCLUDE:

#### POLICY AND MANAGEMENT

- Develop individual Tūpuna Maunga plans to provide direction on how the Values, Pathways, guidelines and strategies should be reflected on each Tūpuna Maunga.
- Progressing the potential transfer of administration over certain Maunga reserve lands from the Department of Conservation to the Authority, and the potential transfer of the administration of land contiguous to other Tūpuna Maunga
- Establishment of a compliance programme including a review of current and establishment of appropriate bylaws.
- Development of individual Tūpuna Maunga plans which reflect the Integrated Values and Pathways, overarching guidelines and strategies for each of the Tūpuna Maunga.

#### HEALING THE MAUNGA

- Implementation of the Education Strategy to promote the values of the Tūpuna Maunga and the unique history and whakapapa of Ngā Mana Whenua. This includes exploration of visitor centre opportunities, connecting with communities of learning such as schools and the development of a communications strategy.

They will also enable a compelling case in a future UNESCO World Heritage bid for the Tūpuna Maunga, which will contribute to a Māori identity that is Auckland's point of difference in the world. The bid for World Heritage status will require a dedicated resource and will continue to be progressed in this financial year in partnership with the Department of Conservation.

#### Whānau Ātea at Te Pane o Mataoho / Te Ara Pūeru / Māngere Mountain

Opening celebration of Māra Hupara including a workshop facilitated by Māori play specialist, Harko Brown, and concluded with hāngī by Hāngi Master, Rewi Spraggon.

#### Maungawhau Boardwalk

The second stage of the Maungawhau boardwalk was opened to the public in late June. The boardwalk represent that latest stage in the protection of the maunga and the provision of a quzlity visitor experience. The mesh and timber boardwalk and platofrms were extedned to the tihi, and a substantial portion of the carpark was converted to an informal, permeable pedestrian and gathering space. The project incorporates a culturally significant planting scheme curated to include native plansts such as aruhe and kumerahou that once would have been prevalent on the maunga.

### **Öhuiarangi perimeter and entranceway improvements**

Purpose	This report:
	a) Present the revised concept plan for the proposed perimeter and entranceway improvements at Ōhuiarangi, and;
	Seek formal endorsement of the revised concept plan.
Recommendations	That the Tūpuna Maunga Authority:
	a) approve the proposed Ohuiarangi Improvements Plan;
	b) <b>note</b> that Management will progress the plans for delivery and report back to the Authority with progress updates.

#### **Background**

- 1. Ongoing recreational mountain biking, unauthorised motorbike use and improper pedestrian circulation within the Maunga has resulted in erosion and exposing of cultural and archaeological features across the site, particularly on the tihi.
- 2. The ongoing issues relating to mountain bike access can be mitigated through the implementation of perimeter fencing which restricts bicycle access, provides formal entranceways with clear path hierarchy, and adequate signage (with track maps).
- 3. This report focusses on the perimeter and entranceway improvements and not the secondary tracks or tihi works. It is noted that the entrace way improvements do not include cultural infrastructure such as Waharoa and this will be address as a future project.

### **Strategic Considerations**

- 4. This paper relates to Ōhuiarangi / Pigeon Mountain.
- 5. Clause 2.3 of the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Deed 2012 states:
  - "2.3 The Tāmaki Makaurau collective legislation will, on the terms provided by section 43 of the draft bill, direct the Registrar-General to record on any computer freehold register for each maunga that the iwi and hapū of Ngā Mana Whenua o Tāmaki Makaurau specified for that maunga in table 1 of part 3 of the property redress schedule have spiritual, ancestral, cultural, customary and historical interests in the maunga."
- 6. The Collective Deed Property Redress Schedule contains the table referred to in clause 2.3, and the iwi/hapū having spiritual, ancestral, cultural, customary and historical interests in the Maunga are as follows:

- 7. The Tūpuna Maunga Authority's Integrated Management Plan (IMP) describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga. The primary focus of the IMP is to protect the health and well-being of the Tūpuna Maunga.
- 8. The IMP the "Values" and "Pathways" achieve a change in the approach to the integrated care and management of Ngā Tūpuna Maunga. Of particular relevance are the following values:
  - a. Mana Whai a Rēhia / Recreational Value The pathways under this value include:
    - i. Provide for recreational activities that are appropriate on the Tūpuna Maunga and compatible with the protection and enhancement of spiritual, historic, ecological, geological, natural and cultural values.
  - b. Wairuatanga / Spiritual Value the pathways under this value include:
    - i. Appropriately locate, design and construct new structures, services, areas of planting and facilities to complement the landform, reduce or minimise visual distractions and respect cultural, historical and spiritual values.
    - ii. Create or maintain pathways and tracks that limit the disturbance of, and impact on the Tūpuna Maunga.
    - iii. Preserve and enhance the authenticity and visual integrity of the Tūpuna Maunga so that they are markers in the landscape, and their cultural and natural features are visually apparent.
  - c. Takotoranga Whenua / Landscape Value the pathways under this value include:
    - i. Support the Tūpuna Maunga Values through the enhancement of the natural environment by reducing erosion and inappropriate surfaces (such as trails, roads and parking areas) and reduce and limit the location of vehicle access.
    - ii. Give people and pedestrian access priority the relationship of people and whenua becomes more real and relevant through touch, feel, sight and safe access on the maunga.
- 9. The Tūpuna Maunga design strategy is based on overarching principles that inform the direction of use and development:
  - a. The tihi is the most sacred part of the Maunga to Mana Whenua. The nature of activities and establishment of structures needs to be carefully managed on the tihi.
  - b. All development will respect and maintain, and where appropriate, enhance and restore the mana of the maunga.
  - c. Existing tracks and structures including infrastructure such as buildings, car parks, trig stations that are inappropriately located or that do not align with the Tūpuna Maunga values will be removed.
  - d. Development will be restricted to that which is necessary to serve the values of the Maunga and the needs of both Mana Whenua and manuhiri (visitors) to the Maunga.
  - e. Development will be designed and located to minimise visual impact and to maintain the pre-eminence of the tihi, Maunga to Maunga sightlines and volcanic viewshafts.
  - f. Development materials and structures will seek to minimise impact on the Maunga and to achieve whole-of-life sustainability including a consideration of decommissioning.
  - g. Materials, colours and scale of development will be appropriate to the context and reflect the natural and/or cultural environment of the locality.
  - h. Impervious areas are progressively reduced to minimise erosion and stormwater generation facilitating more natural water systems

- i. Boundaries and edges Fences and barriers may be required to mark boundaries and edges, particularly given most of the Maunga are situated in suburban environments. These may also be required for safety and to protect areas of cultural or ecological significance in order to enable the Maunga visitors to make appropriate choices about how to move around the Maunga.
  - Where fences and barriers are used these should be of a style, materials and height that are appropriate for the situation. Volcanic rock walls have been used in many places and continue to be appropriate to mark boundaries. On some Maunga, a fence design more akin to the palisades from pā may be acceptable.
  - Boundaries and edges on the Maunga: guidance for appropriate location and design of fences and barriers, and materials.
  - Location: fences or walls will be located to mark the boundaries of the area within
    the jurisdiction of the Tūpuna Maunga Authority, to protect areas of cultural or
    ecological significance from disturbance and to demarcate the edges of roads
    where necessary for safety. Boundary fences should be cat and predator proof.
  - Design: tie the design into the natural landform and landscape where practical, and with consideration of the barrier function.
     Materials: natural site elements and locally eco-sourced planting are the preferred materials to demarcate boundaries and edges. Where solid barriers are constructed, soften these with planting.
- j. At Hui 85 (10 July 2023) the Individual Maunga Plan was approved. It indicates that fencing and barriers will be included.

#### **Proposed changes**

- 10. Attachment A presents the proposed alignment of perimeter fencing, entranceways, and overall boundary treatments around the Maunga and adjacent wetland. The number and location of entrance ways takes into consideration the main access points, a need to prevent new desire lines establishing and the need to provide multiple entry and exit points to enable personal safety.
- 11. Each set of actions is discussed in more detail below.

#### 12. Actions include:

- a) 1.2-meter-high Brustics Eucalypt fencing around the south, west, and eastern boundaries. 0.9-meter-high fencing will be applied to areas where sight lines need to be maintained for CPTED reasons. This includes the eastern boundary of the adjacent wetland. It is proposed that the treatment between fencing and boundary is to be native planting. Once the planting has sufficiently established in the future, there may be an option to remove the fencing or parts thereof given that the fencing construction is considered low-impact and easily removable. These fences have been utilised at the Te Pane a Mataoho/ Te Ara Pūeru / Māngere Mountain Whanau Ātea to great effect.
- b) Fencing restricts mountain bike and motorbike access and controls formal ingress and egress into the Maunga.
- c) Formalizing of main, minor, and maintenance entranceways along the perimeter of the Maunga and adjacent wetland. This consists of the following:
  - 3 main pedestrian entrances with pram/wheelchair friendly gate.
  - 2 maintenance entrances.
  - 9 minor entrances.
- d) Introduction of a pedestrian path and boxed steps interfacing with existing off-street parking at the south-west corner of Gills Road. This provides safe access into the Maunga for pedestrians which avoids the need to walk within the road corridor.
- e) Design and installation of wayfinding, interpretive, and regulatory signage/features at key entrance points, in line with the TMA signage design guidelines.


- f) A comprehensive CPTED (Crime Prevention Through Environmental Design) assessment has been carried out to identify risks and recommendations associated to the design. The fencing materiality is appropriate to the context of the site and ensures visibility and sight lines are maintained for CPTED reasons. This will be a continued focus throughout the design phase.
- g) Planting along the southern-eastern slope of the Maunga will prevent improper pedestrian access and further erosion. Rock garden planting options have also been incorporated around the entire perimeter of the Maunga with the intention sections of the Brustics fencing can be removed once the planting has sufficiently established.
- h) Management have considered a range of footing options that can be utilised as part of the project. Footing options include:
  - Utilising existing footings so that further ground penetration is required
  - Utilise screw pile or no-dig technology footings.
- i) Permanent signage will be installed to support the no mountain biking message.
- j) Pram and wheel chair accessible entrances without gates have been incorporated into the design.

#### **Next steps**

- 13. Staff to proceed with the developed, and detailed design stages in preparation for delivery.
- 14. Report back to a future Authority hui to provide progress updates.









Purpose	To consider the Matukutūruru Predator Proof Fence Concepts	
Recommendations	That the Tūpuna Maunga Authority:	
	a) <b>adopt</b> the design concepts for the Matukutūruru Predator Proof Fence.	
	b) <b>note</b> that Management will continue working with Mana Whenua and stakeholders on the detailed design and implementation of the project.	

#### **Background**

- 1. The Tūpuna Maunga Authority considers the enhancement of the ecological and biodiversity values of the Tūpuna Maunga a crucial aspect of the restoration of the health and well being of the Tūpuna Maunga.
- 2. To enable this several biosecurity programmes are underway including pest control programmes across the Tūpuna Maunga managing pest species such as rats, mice, mustelids, and rabbits.
- 3. The Authority has always championed the Maunga becoming pest free and have been supportive of initiatives including Predator Free New Zealand and the Pest Free Auckland initiatives delivered by Auckland Council.
- 4. An important tool in the delivery of pest free Maunga is the utilisation of Predator Proof fencing.
- 5. Matukutūruru has been identified as a Maunga where a predator proof fence could be installed.

### **Statutory Considerations**

- 6. This paper relates to Matukutūruru.
- 7. Clause 2.3 of the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Deed 2012 states:
  - "2.3 The Tāmaki Makaurau collective legislation will, on the terms provided by section 43 of the draft bill, direct the Registrar-General to record on any computer freehold register for each maunga that the iwi and hapū of Ngā Mana Whenua o Tāmaki Makaurau specified for that maunga in table 1 of part 3 of the property redress schedule have spiritual, ancestral, cultural, customary and historical interests in the maunga."
- 8. The Collective Deed Property Redress Schedule contains the table referred to in clause 2.3, and the iwi/hapū having spiritual, ancestral, cultural, customary and historical interests:

- 9. The Tūpuna Maunga Authority's Integrated Management Plan (IMP) Is the Reserves Management Plan required by the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and the Reserves Act 1977.
- 10. The integrated Management plan was adopted in 2016 and amended in 2022 both following Auckland wide public engagement, submission and hearing processes as outlined in the Reserves Act 1977
- 11. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga. The primary focus of the IMP is to protect the health and well-being of the Tūpuna Maunga.
- 12. As outlined above, The Mauri Pūnaha Horopi value and pathway states:
  - a. Reintroduce or attract indigenous species to the Tūpuna Maunga including microorganisms, invertebrates, lizards, and birds, as all of these contribute to resilient and healthy ecosystems.
  - b. Remove invasive plant and animal pests.
    - The Takotoranga Whenua / Landscape Value and pathways states:
  - c. Increase the biodiversity, structural diversity and native habitat values of the Tūpuna Maunga and their hinterland by enhancing plant health, soil health, native food resources and habitat connectivity through the development and implementation of an ecological restoration strategy.
  - d. Establish and enhance opportunities for wildlife connections including the development and enhancement of safe and effective wildlife mitigation routes for birds, other fauna, and plant species between maunga.
- 13. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga Design, Recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.
- 14. Section 5.3 of the biodiversity states:
  - "Restoration will incorporate traditional indigenous flora and fauna, with the intention of providing for increased biodiversity, cultivation and cultural harvesting of kai, medicinal, textile materials, and other cultural requirements. Propagation and captive management of flora and fauna may be a component of the strategy for some Maunga. Vegetation restoration should be tailored to achieve the specific outcomes and purposes proposed for each individual Maunga. Restoration will also extend beyond Tūpuna Maunga, to include: community involvement with integrated restoration programmes that maximise biodiversity and develop ecological connections and biodiversity corridors between Maunga and the Hauraki Gulf, Hunua and the Waitakere Ranges. Provide opportunities and identify possible projects that tamariki and rangatahi from local schools and tertiary institutions can engage in and contribute to increase restoration and biodiversity outcomes."
- 15. Section 6.3.1 of the Biosecurity Strategy states:
  - "Through the Individual Maunga Plans identify and implement small areas (<2 ha) of predator proof fences, for appropriate Maunga depending on the target species suitable for reintroduction. Each area will be specifically designed to link into biodiversity protection in [section] 5.3 (i.e, those areas which have been specifically selected for restoration of habitats or species). Predator proof fences will be established around these areas and all pest species will be removed prior to restoration activities occurring. This would create a sanctuary for the protection and introduction of native plant and animal species without the pressures of predation, competition or herbivory from these introduced threats. Additional biosecurity and monitoring practices, such as the regular use of rodent dogs, traps and bait stations will also be implemented to effectively mitigate any ongoing incursion issue from mice. These predator proof areas will serve as 'sanctuary' sites for threatened native

species and will allow for enhancing the existing fauna and the safe reintroduction of rare native flora and fauna (particularly lizards and potentially some birds where appropriate habitats can be established)".

- 16. The Matukutūruru Individual Maunga Plan was approved at Hui 85 (10 July 2023), following public consultation. The Plan identifies the potential establishment of pest proof fencing within 3 to 10 years.
- 17. At Hui 30 (16 October 2017) The Authority agreed to administer and manage the Wiri Lava Cave subject to the Te Ākitai Waiohua Treaty Settlement. The proposed design incorporates that piece of land into the final design.

### **Predator Fencing Objectives**

- 18. Management have considered the following objectives when establishing this project, with the understanding that these will most likely further evolve as we gain more knowledge and receive further feedback from the Authority:
  - a. Look at options to eradicate the majority of predators from the Maunga including: Rodents (Ship Rats, Norway Rat, Mice) Hedgehogs, Possum, Mustelids (Stoats, Ferrets, Skinks) Cat, Leporides (Rabbits, Hares)
  - b. Look at options to establish a predator free sanctuary that can be utilised as a habitat for animal species such as; weka, and mokomoko (copper skink, moko skink, and elegant and pacific gecko and Duvaucels gecko). Note that these species have all been identified in the Tūpuna Maunga Biodiversity Strategy for potential return to the Tūpuna Maunga.
  - c. Establish a translocation sanctuary that can be utilised by other stakeholders such as Auckland Zoo.
  - d. Support the Tūpuna Maunga Authority Integrated Management Plan biodiversity outcomes and strategy by having a sanctuary that supports biodiversity recovery.
  - e. Support the Tūpuna Maunga Authority Integrated Management Plan Education Strategy by establishing an environment that can be used to achieve learning outcomes.

### **Predator Proof Design Specifications**

- 19. The recommended design will create a perimeter proof fence around the entire of the reserve and the adjoining Wiri Lava Cave Scientific Reserve. As such Management will continue to engage with Te Āki Tai Waiohua on the final design of the project.
- 20. Management will also continue to engage with key stakeholders including the Department of Conservation and Auckland Zoo on design requirements for the project.
- 21. The design will also contain the following features:
  - Poles these are 50mm aluminium.
  - Mesh 316 grade stainless steel, 24x6 millimetre gauge.
  - Fence hood cap.
  - Aluminium componentry Fixings and fittings.
  - Double gated pedestrian cage.
  - Vehicle access gate access provision for maintenance teams.

### **Operational Models.**

- 22. There are approximately 35 predator fencing sanctuaries across New Zealand. Many of these sanctuaries are managed with and without onsite staff. Management have reviewed three options for future operational models of Matukutūruru:
  - Unstaffed option
  - A Volunteer managed sanctuary with staff support.

- Fully staffed option.
- 23. The unstaffed option is the least expensive option and simplest to implement. A new predator proof fence would require regular checks (weekly, fortnightly or monthly). There would be occasional response maintenance costs if there is vandalism or incidents whereby the fence is damaged. The main disadvantage of an unstaffed site is security risk. In particular, there would be risks to any endangered species that may be introduced to the site in the future. This would mean a prudent approach to reintroduction of native species in the first instance.
- 24. A volunteer managed site could be implemented over time as public awareness of the new predator proof fence grows and volunteer support comes online. It is noted that there are certain responsibilities under the Health and Safety at Work Act 2015 and volunteers of this nature would be treated as workers. There would also be extra work required regarding rostering and people management. A volunteer managed site would help meet some of the objectives of the predator proof fencing objectives. In particular, it would help meet objectives outlined in the Tūpuna Maunga Education Strategy and allow for the site to be utilised as a sanctuary for endangered species by increasing on site presence and therefore security. To implement this option an investment would need to be made into facilities for staff including shelter and toilets.
- 25. The third option is for a fully staffed site. This could be achieved in several ways. Firstly, through direct employment of the Tūpuna Maunga Management Team. The second is by way of a contractual arrangement with a third party who could potentially deliver visitor engagement and site management services on behalf of the Tūpuna Maunga Authority or through a concession opportunity whereby a third party is engaged to run a sanctuary as a business. The fully staff-managed option would take some time to develop the appropriate operational procedures and infrastructure facilities. A fully staffed site would meet the full objectives of the site as well as offer extra employment opportunities to Mana Whenua and the community. However this would also be the most expensive and complicated option.
- 26. It is the recommendation of Management that the site is initially a non-staff managed site but over time the Authority could look towards the site incorporating volunteer support and on-site staff into the operation as resources allow.

### Te Pane a Mataaho, Te Ara Püeru, Mängere mountain rua protection

Author/s: Elizabeth Parkin, Kaihautū Hōtaka

Purpose	This report presents a proposal to protect an important area of rua on the small crater edge at Te Pane a Mataaho, Te Ara Pūeru, Māngere mountain.
Recommendations	That the Tūpuna Maunga Authority:  a) <b>approve</b> the concepts outline in the report and included as attachment A, for detailed design and construction.

### **Background**

- 1. The recently upgraded loop track to the tihi of Te Pane a Mataaho, Te Ara Pūeru, Māngere mountain was the first of a series of projects to help protect the Maunga from further damage, and to improve the pedestrian experience.
- 2. This project is concerned with a complex area of tracks woven through rua on the rim of the smaller crater. Informal tracks in this area are damaging the form of the rua, and the crater's edge. The project offers an opportunity to prevent further damage and present the rua in a more considered way for interpretation and education.
- 3. Sections of aggregate track, and timber boardwalk on screwpiles are proposed along the craters edge. Reclaimed basalt will be used to form steps and path edges.
- 4. This paper relates to Te Pane a Mataaho, Te Ara Pūeru, Māngere mountain
- 5. Clause 2.3 of the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Deed 2012 states:
  - "2.3 The Tāmaki Makaurau collective legislation will, on the terms provided by section 43 of the draft bill, direct the Registrar-General to record on any computer freehold register for each maunga that the iwi and hapū of Ngā Mana Whenua o Tāmaki Makaurau specified for that maunga in table 1 of part 3 of the property redress schedule have spiritual, ancestral, cultural, customary and historical interests in the maunga."
- 6. The Collective Deed Property Redress Schedule contains the table referred to in clause 2.3, and the iwi/hapū having spiritual, ancestral, cultural, customary and historical interests in Te Pane a Mataaho, Te Ara Pūeru, Māngere mountain are as follows:

Te Ara Pueru /	Ngāi Tai ki Tāmaki, Ngāti Maru, Ngāti Tamaoho, Ngāti Tamaterā, Ngāti Te

### **Strategic Considerations**

7. The Tūpuna Maunga Authority's Integrated Management Plan (IMP) was adopted by the Authority in terms of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and the Reserves Act 1977 at Hui 19 (23 June 2016). The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga. The primary focus of the IMP is to protect the health and well-being of the Tūpuna Maunga. The "protection and enhancement of the mauri and wairua of the Tūpuna Maunga is paramount" (p57).

- 8. When considering new works the Wairuatanga / Spiritual value guides the Authority to:
  - "Appropriately locate, design and construct new structures, services, areas of planting and facilities to complement the landform, reduce or minimise visual distractions and respect cultural historical and spiritual values" (p58).
- 9. The Tūpuna Maunga Strategies were approved by the Authority at Hui 50 (25 September 2019). The design strategy provides parameters for development on the Maunga to ensure that it respects and responds to the underlying cultural, natural and historic heritage values. The following specific principles are relevant:
  - a. All development will respect and maintain, and where appropriate, enhance and restore the mana of the Maunga.
  - b. Development will be restricted to that which is necessary to serve the values of the Maunga and the needs of both Mana Whenua and manuhiri to the Maunga.
  - c. Development materials and structures will seek to minimise impact on the Maunga and to achieve whole-of-life sustainability including a consideration of decommissioning.
  - d. Materials, colours and scale of development will be appropriate to the context and reflect the natural and/or cultural environment of the locality.
  - e. Impervious areas are progressively reduced to minimise erosion and stormwater generation facilitating more natural water systems.

### **Design details**

- 10. Attachment A presents the full concepts for the proposal. The design chosen represents the 'lightest touch' approach to addressing the damaging desire lines. The boardwalk and tracks work together to lift pedestrians above the archaeological features, allow for comfortable two-way traffic on the paths, and present an opportunity educate on the significance of the rua. A safety from falling barrier is anticipated on the inside edge of the boardwalk sections. Temporary fences will be used to reinforce the designated paths once construction is complete.
- 11. The materials and construction techniques depicted in the concept are the same as have been used on this and other Maunga and include:
  - a. Compacted aggregate tracks,
  - b. Rock placement for stairs and edges,
  - c. Timber boardwalk on removable screwpiles, and
  - d. Timber and mesh platforms
- 12. Management note that closing the tracks through the rua and along the crater edge was also an option considered. The success of such a closure was thought to be unlikely given the appeal of the crater's edge and the intransigence of the tracks to date.


